Terms and conditions for BSA Organisation Membership

The aim of these terms and conditions is to foster partnership and collaboration in the pursuit of achieving the BSA vision and mission. Through joining, the BSA as an organisation member indicates acceptance of our terms and conditions.

- Endorsement** - BSA Organisation Membership no way implies endorsement of the company or its products by the British Society of Audiology
- Applications** - An application for membership may be refused or withdrawn if the application does not meet membership criteria
- Payment** - Payment for organisation membership must be made within 30 days of receipt of invoice. Your organisation membership will lapse if you do not pay us within three months of the original invoice date. Organisation membership payments are non-refundable. Membership will not commence, and membership benefits will not start until full payment has cleared.
- Fees** - The fees will be reviewed annually and any proposed changes will be sent to you in writing
- Conferences** - Organisation members enjoy significant discounts on places at BSA Learning Events.
