Nov 2023 BSA Cognition in Hearing Special Interest Group (CH SIG)

The CH SIG is a multi-disciplinary group with overlapping interests in the cognitive processes that are involved in listening to and understanding sounds, including attention, memory, learning and decision making. The current CH SIG committee have specific interests in dementia and cognitive decline, tinnitus and hyperacusis, listening effort and improving access and clinical practice for underserved patient groups (adults with Intellectual Disabilities, patients with Autism Spectrum Disorder, people with dementia).

Dementia Network. The 3rd Dementia Network event on "Hearing rehabilitation for people with dementia" took place on 13th September and was led by Jenny Douglas.

Our guest speaker was Sonia Archer; she is an occupational therapist by trade and now the Dementia lead for York and Scarborough NHS trust. Her talk focused on rehabilitation and management considerations for people with dementia with regards to the effects of dementia on different parts of our brain and senses. This was followed on by a case study presented by Helen Flett and the use of speech testing for people with dementia as a rehabilitation tool and form of assessment of benefit of hearing aids.

Discussion from our attendees suggested that a useful output from the event would be to provide some hints and tips on effective or alternative rehabilitation management or tools when providing audiological management for people with dementia. To collate this information there was a Padlet wall where attendees added their suggestions to.

We would like to continue to gather advice from those who work with, and who are interested in, audiological rehabilitation for people with dementia but were not able to attend the event in September.
